
## **UBB ExpertEase Dynamic Balanced (EUR)**

UBB ExpertEase Dynamic Balanced (EUR) is a global mixed "balanced" investment sub-fund of the umbrella mutual fund UBB ExpertEase, which is a feeder collective investment scheme within the meaning of Article 67 of the Law on the Activity of Collective Investment Schemes and Other Collective Investment Enterprises (LACISOCIE). The investment objective of the sub-fund is to invest at least 85% of its assets in the main sub-fund and up to 15% of its assets in cash and derivatives. The main sub-fund Horizon ExpertEase Dynamic Balanced follow a multi-signal strategy which investment objective is to generate the highest possible return for its shareholders in accordance with its investment policy. The main sub-fund Horizon KBC ExpertEase Dynamic Balanced folows multi-signal strategy in which the target allocation is 55% equities and 45% bonds.
